- For highly motivated students looking to thrive in their studies and require a highlevel ATAR to access their desired University course.
- Offers an outreach program with tutorial sessions outside regular class hours.
- Ideal for students considering extension subjects.
- Features academic immersion through day excursions.
- Provides internal support for early entries and external testing opportunities, including UCAT, GMSAT, and LAT.
- Assists with attending university open days and information seminars.
- Offers support for alternative or overseas university entrance exams.
- Provides advice on subject packaging.
- Participation in Elevate Study Skills workshops.

- **3. Modern History:** *Why?* History helps Sarah develop her research skills, understand the context of legal systems, and improve her ability to construct arguments based on evidence.
- **4. Economics:** Why? Economics offers insight into how laws affect society, particularly in areas such as trade, finance, and policy-making. It also enhances Sarah's analytical and problemsolving skills.
- **5. Mathematics Advanced:** *Why?* Good maths skills are useful for developing logical thinking and understanding statistics, which can be important in legal studies and practice.
- **6. Studies of Religion I:** Why? This subject provides Sarah with an understanding of ethical issues and cultural perspectives, which are important in the study of law, especially in areas like human rights and international law.

She chooses subjects that she enjoys and is good at, as this will help her achieve strong results. Additionally, Sarah plans to participate in co-curricular activities like the debating team and mock trial competitions, which will help her develop skills that are valuable in law, such as public speaking, argumentation, and critical thinking.
